

The Great Chazy Lake Pike Out Event
August 31 & September 1, 2024



EVENT RULES

1. The Great Chazy Lake Pike Out Event ("Event") will be held on Saturday, August 31, 2024, and Sunday, September 1, 2024, from 6:00 AM to 2:00 PM.
2. All fishing must occur on Chazy Lake ONLY.
3. All NYS DEC laws, and NYS Boating Laws apply to the Event.
4. All registrants must bring their fish to the weigh-in/measuring station, which will be located at the Chazy Lake State Boat Launch, no later than 2:30 PM on both Saturday (8/31) and Sunday (9/1) to be in contention for prizes. Any fish arriving at the State Boat Launch after 2:30 PM will not be considered for contention. All fish must be alive when weighed-in/measured and cannot show any signs of being dismembered, tampered, or otherwise altered to affect the weight and/or length of the fish. Any person(s) found to be involved in any of the above-listed acts will be disqualified from the Event and will not be welcomed to future fishing events.
5. All fish submitted for contention will be dispatched after weigh-in/measuring. Weight and length data will be collected to help understand the current state of the Northern Pike fishery in Chazy Lake. Anglers have the right to take their catch with them or donate their catch to the Chazy Lake Watershed Initiative.
6. In consideration for receiving permission to participate in the Event, I hereby release, waive, discharge, and covenant not to sue Chazy Lake Watershed Initiative ("CLWI"), its officers, directors, employees, agents, and sponsors (hereinafter referred to as "Released Parties") from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or relating to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of the Released Parties, or otherwise, while participating in the Event, or while in, on or upon the premises where the Event is being conducted, while in transit to or from the premises, or in any place or places connected with the Event.
7. I am fully aware of risks and hazards connected with being on the premises and participating in the Event, and I am fully aware that there may be risks and hazards unknown to me connected with being on the premises and participating in the Event, and I hereby elect to voluntarily participate in the Event, to enter upon the Event premises and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage, or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, because of my being a participant in the Event, whether caused by the negligence of the Released Parties, or otherwise.
8. I further hereby agree to indemnify, defend, and hold harmless the Released Parties from any loss, liability, damage, or costs they may incur due to my participation in the Event, whether caused by the negligence of any or all the Released Parties, or otherwise.
9. It is my intent that this Release is binding upon me, the members of my family (including my spouse, if any), my heirs, assigns, and personal representatives.
10. CLWI reserves the right to modify the Event Rules in its sole discretion.
11. The longest fish dispatched at the State Boat Launch will win the Event. In the event of a tie based on the length of the fish, the fish with the highest weight will win the Event. In the event of a tie on both length and weight of the fish, CLWI will determine the winner of the Event in its sole discretion.
12. Each fish will be counted as one entry for the raffle prize.
